

# GENERAL RULES

2025

## Membership

Golf, Social, and Social-Pool memberships are available at the Club. LeSueur Country Club, in the Membership's best interest, has limited the number of Golfing Members to 350. The Membership Year is defined as the calendar year.

## **Resignation Policy**

All active Members and their Subscriptions (annual cart fees, club storage, lockers, and handicap) will be re-enrolled unless notified in writing by December 31<sup>st</sup>. Members who wish to resign must notify the Club in writing prior to the end of the calendar year. If notification is received after the end of the calendar year, yet prior to April 1<sup>st</sup>, the annual dues will be waived; however, the stock value will be forfeited to the Club. If notification is received after the first of April, payment of the annual golf dues will be required. Golf members wishing to change to a Social membership may notify the Club of their intent and upon approval, the dues rate will be changed to the appropriate amount. Social members wishing to change to a Golf membership may notify the Club of their intent and upon approval the dues rate will be changed to the appropriate amount. If the notification is received prior to August 1<sup>st</sup> the annual golf member dues will be charged. If notification is received after August 1<sup>st</sup>, the golf dues will be charged pro rata for the balance of the year.

#### **Stock Subscription**

A stock subscription of one share of stock, valued at \$300, is also required of all adult stockholding golf and social members.

# **Spending Requirement**

Stock holding Golf Members must spend a minimum of \$375.00 (Single Memberships) / \$500.00 (Family or Dual Memberships) in the Clubhouse on **FOOD ONLY** during the golf season. Purchases must be charged to the stockholder's member account. Tax and gratuity do not apply toward minimum. Any accounts not reaching this food requirement will be billed by the end of the calendar year for the balance.

### **Credit Policy**

The business office at the Club prepares a monthly billing statement at the end of every month. This statement will include all charges made at the Club for that month, plus the dues for the next month (for those members choosing to have their annual dues billed on a monthly basis). The payment of this balance is required to maintain your membership status at the Club. Disputes may be registered within 30 days after receipt of statement. Member charge accounts that are not paid in full by the last day of the month in which the billing statement is received are "past due" and subject to a finance charge of 1.5 % of the "past due" balance. Member charge accounts that are not paid in full by the end of the second month, after receipt of the billing statement, are considered "delinquent". Golfing and charging privileges will be revoked to accounts deemed to be delinquent until all "delinquent" payments are received. Further if payment of "delinquent" charge amounts is not received by the next meeting of the Board of Directors, the membership will be "suspended" and legal action will begin for collection of the entire balance owed by the member charge account. A 3% convenience fee is added to account charges settled by credit card. There is not a fee for ACH payments, and these fees do not apply to daily credit card transactions.

# **GOLF SERVICES**

#### **Tee Time Reservations**

Members may book tee times up to **two weeks** in advance. Reservations may be made online or via the Golf Shop. When booking tee times please provide the names of all other players in your group. Singles and twosomes may be paired up to ensure a good pace of play and minimize waiting on the golf course. Effort will be made to pair players with similar preferences. Please call and cancel any tee times, including standing times on Ladies' Day and Men's Day, so these times can be utilized by others.

Ladies' League runs from late May through August on Wednesdays. During this time frame, men may book tee times before 1:30 pm and after 2:30 pm.

Thursdays are Men's Days. Women may book tee times before 10:00am and after 4:30pm. Between 10:00 and 4:30, all golfers on Thursdays must be 19 years of age or older.

Tee times, and tee time availability, on Wednesdays and Thursdays are established according to the amount of play by women and men on respective days. In early spring and late fall tee times, outside of the above parameters, may be booked at the discretion of the Head Golf Professional.

## **Guest and Non-Member Play**

Members are encouraged to bring guests to play at the Club. No punch cards are available but accompanied guests are now unlimited and at the specified guest rate.

Non-Member guests may play, based on availability, Monday – Sunday by making a tee time up to **one week** (seven days in advance).

#### **Cellular Phones**

Cellular service is limited in our location. Free wi-fi is available in and around the Clubhouse. Please respect others when using your mobile phone in the clubhouse and on the course.

## **Appropriate Golf Attire**

Please observe "Country Club Relaxed" attire in the restaurant and on the golf course and practice facility. Men's and ladies' tops should include a collar or finished edge. Denim pants are acceptable in good condition at the discretion of Club Management. Gym and swim attire is not acceptable other than in the pool area and locker rooms. Shoes are required other than in the pool area and should not allow for damage to the grounds.

## **Golf Carts**

Any operator must have a valid driver's license. All golf cart operators will follow the rules established by Le Sueur Country Club or privileges will be revoked. When operating golf carts, stay behind the white lines and on cart paths where provided. Please use seed and soil provided on the golf carts to fill divots.

The Club allows the usage of both Club-owned and Member-owned golf carts. The Club's fleet of golf carts may be rented per round for posted fees or for a pre-paid season rate. Member-owned carts may be stored in the Club's cart garages for an annual fee.

Strictures of fees coverage:

- Single Seasonal the identified Member only.
- Family Seasonal any two people under the Membership per day. Cart fees assessed to additional family Members after two each day. Does not cover guests or other Members.
- Cart Storage the owner and spouse or equivalent plus one additional rider.
- Cart Storage with another Member either owner and spouse or equivalent plus one additional rider.
  - \*Players using a member owned cart without the Member are subject to cart fees.
  - \*Shared cart use is required for the health of our course. Twosomes will share 1 cart; Threesomes and Foursome will share 2.

## **Beverage Cart:**

A beverage cart will operate with sufficient play. Play passes the Clubhouse after hole #9; please keep your turn brief. No alcoholic beverages may be brought to or removed from the property.

## Golf Club & Pull Cart Storage

The Golf Shop offers golf club storage and cleaning for an annual fee. Pull cart storage is provided to those storing golf clubs at an additional annual fee.

#### **Practice Facilities**

A practice range, putting green, practice bunkers, and chipping green are provided for use free of charge to Members and their guests. Non-members may practice without a paid greens fee for a daily usage fee.

#### **Golf Course Maintenance and Maintenance Staff**

We ask that all golf members and guests do their part in maintaining the beautiful golf course conditions that we enjoy at the Club. Members and guests are required to know and follow the "player's responsibilities" for taking care of our course.

## U.S.G.A. GHIN Handicap System

All golf members may join the Minnesota Golf Association and establish a GHIN index for a handicap. The Golf Shop staff will assist you in establishing this index. A dedicated computer is located in the Golf Shop for the purpose of entering scores into this system. The USGA GHIN app is available to download.

## **Golf Shop Merchandising**

The Head Golf Professional runs the merchandising operation as a service to the members. Golf equipment, supplies and apparel are available for ladies and men. Manufacturer demo days may be scheduled based on demand and company availability. The Club encourages its members to support this entity throughout the golf season. Club Tournament prizes are redeemed for merchandise from the Golf Shop. These credits will expire at the end of the season they are awarded.

#### **Golf Lessons**

Golf Instruction is available by appointment. Contact the Head Golf Professional for more information. Group lessons and clinics are offered on occasion or can be arranged for parties of 4 or more.

## **Golf Events**

The Golf Committee and the Head Golf Professional plan and administer a full schedule of events throughout the season. Highlights of the schedule include the Guest Days, Pro-Am, Ladies Invitational, Tri-Play, Holiday Golf Mixers (Memorial Day, the Fourth of July and Labor Day) and the Club Championships.

#### **Gratuities**

Gratuities are permitted and appreciated by the staff.

## SWIMMING POOL

The swimming pool is open for members and guests from the last weekend in May or early June through Labor Day. The pool will be open from Noon to 8:00 p.m., weather permitting. All children 12 and under must have adult supervision. **No Lifeguards on duty.** 

# **CLUBHOUSE SERVICES**

The Clubhouse is open for service from April through October. Limited service may be available in peripheral months or arranged with the Clubhouse Manager.

#### **Locker Rooms**

Locker Rooms including restrooms, shower rooms, vanity counters and towel service are provided for both men and women in the Clubhouse. An annual locker rental fee is required for those members wishing to have a locker. The Club is not responsible for lost or damaged personal property.

#### **Bar and Restaurant Services**

Regular hours for bar and restaurant services will be posted and are subject to change based on weather and special events. All food and beverages must be purchased from the Clubhouse. Violation of this rule is subject to removal from the facility. Alcohol purchased from the Club may not be removed from the property.

All members who use their Club account are requested to sign and retain a copy of each charge transaction. All transactions will automatically have a 15% gratuity added; however, you may fill-in an additional gratuity amount if desired on exceptional service.

## **Banquet and Catering Policies**

The clubhouse includes two dining rooms, a casual lounge, a bar and a patio area for the enjoyment of members and guests. Groups up to 140 guests fit comfortably in the dining areas of the clubhouse. Wedding ceremonies and receptions may be held at the Club. Outdoor tent areas are available. Reservations may be made up to one year in advance. A \$ 250 deposit is required to reserve the use of the entire Clubhouse facilities. All menu prices are subject to applicable sales tax and service charge.
