Clubhouse Minimum Spending Requirement: All Stockholding Golf Memberships are required to spend a minimum on food from March 1 - October 31. Single membership \$200, Dual membership \$225, Family membership \$260. All purchases must be charged to the member account. Beverages, tax and gratuity do not apply toward annual food minimum.

Membership requires a valid credit card on file with the Club office.

Enrollment in the automatic payment program is required to qualify for monthly billing of membership dues. One-time annual dues payments do not require enrollment in auto pay.

Stock Purchase: Stockholding members are required to purchase stock in the amount of \$300. This purchase entitles the active member to credit privileges in the Clubhouse and Golf Shop, and voting rights at all stockholder meetings / club elections.

Dues and fees are subject to the applicable state and local sales tax.
